3. That, at the discretion of the Entertainment Committee, requested artist fees or time slots may be adjusted or may not be granted.
4. If selected, to perform on June 7, 2020 and to report to the assigned Stage Manager at least 40 minutes prior to the assigned time slot, and that short-notice schedule adjustments may be necessary.
5. That the applicant's performance shall be suitable for family audiences and children.
6. That the Entertainment Committee reserves the right to exclude any applicant.
7. That the Entertainment Committee reserves the right to cancel or terminate any scheduled performance for non-compliance with this agreement or with the policies of the Filipino Fiesta of Sacramento, even on the day of the event.
8. That the applicant shall not hold Filipino Fiesta of Sacramento liable for any personal injury or loss, or property damage or loss, resulting from the applicant's participation in Filipino Fiesta of Sacramento 2020.
9. That the Entertainment Committee shall confirm entertainer selections and time slots no later than May 24, 2020 and that entertainer who are not selected shall be notified accordingly.
10. That the individual signing below is of legal age and, if acting as an applicant's representative, shall be responsible for ensuring that the applicant fully understands this agreement and for ensuring that the applicant receives and understands all other information that the Entertainment Committee may provide to the signer in relation to this agreement.
