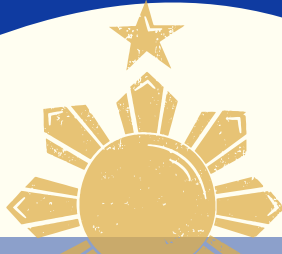

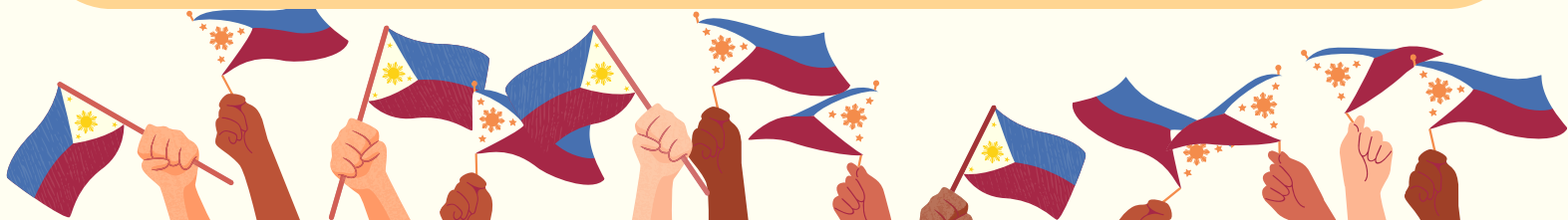

ARTIST AGREEMENTS & UNDERSTANDINGS

- Artists agree to comply with all the policies of Filipino Fiesta of Sacramento 2024.
- All decisions of FFS 2024 regarding selection, scheduling, and honoraria are final.
- Requested artist fees or time slots may be adjusted or not be granted at the discretion of FFS 2024.
- Acts shall be suitable for family audiences and children.
- FFS 2024 shall confirm artists/ acts and time slots no later than **May 19, 2024**, and applicants not selected shall be notified accordingly.
- If selected, artists will report to the assigned Stage Manager at least 40 minutes before the assigned performance time slot on **June 2, 2024**.
- Acts/ artists understand that short-notice schedule adjustments may be needed up to and including on the event day.
- Artists and their representatives shall not hold FFS 2024 or any officer/ representative performing duties on behalf of FFS 2024 liable for any personal injury or loss, or property damage or loss, resulting from the applicant's participation in FFS 2024.
- FFS 2024 reserves the right to exclude any applicant.
- FFS 2024 reserves the right to cancel or terminate any scheduled act/ artist for non-compliance with this agreement or FFS 2024 policies, including up to the day of the event.

By signing below, you acknowledge that you are age 18 or older. If you are under the age of 18, you will need to designate an adult representative to accept this agreement for you. Applicants or their adult representatives are responsible for ensuring the acts/ artists fully understand this agreement.
